STATUTORY RULES AND ORDERS NO. 23 OF 2022.

REGULATIONS

MADE by the Minister under section 20 of the Commonwealth of Dominica Citizenship Act, Chapter 1:10.

(Gazetted 18th August, 2022.)

1. (1) These Regulations may be cited as the –

Short title and commencement.

(2) These Regulations come into force on the 15th day of September, 2022.

2. In these Regulations the Commonwealth of Dominica Citizenship by Investment Regulations, 2014 are referred to as “the Principal Regulations”.

Interpretation.
[S.R.O. No. 37 of 2014].

3. Regulation 2 of the Principal Regulations is amended by deleting the definition of “dependant” and substituting the following –

Amendment of regulation 2.

““dependant” means —

- (a) a spouse of the main applicant;
- (b) a child under eighteen years of age of the main applicant or the spouse of the main applicant;
- (c) a child of the main applicant or the spouse of the main applicant between eighteen and thirty years who is in

attendance at a recognised institution of higher learning and substantially supported by the main applicant or the spouse of the main applicant;

- (d) an unmarried daughter of the main applicant or the spouse of the main applicant who is under twenty-five years of age and is living with and fully supported by the main applicant or the spouse of the main applicant;
- (e) a child of the main applicant or the spouse of the main applicant who is eighteen years of age or older and physically or mentally challenged and who is substantially supported by the main applicant or the spouse of the main applicant;
- (f) parents or grandparents of the main applicant or the spouse of the main applicant above the age of sixty-five years who are substantially supported by the main applicant or the spouse of the main applicant;”.

Amendment of the
Schedule to the
Principal Regulations.

4. The Schedule to the Principal Regulations is amended in paragraph 1 by deleting subparagraph 2 (a) and (b) and substituting the following –

- “(a) on approval in principle of an application through a real estate investment or other approved project –
 - (i) twenty-five thousand United States dollars for the main applicant;
 - (ii) thirty-five thousand United States dollars for the main applicant and up to three dependants;
 - (iii) fifty thousand United States dollars for the main applicant and up to five dependants;

(iv) twenty-five thousand United States dollars for any additional qualified dependant;

(b) to qualify persons through a direct monetary investment an amount of –

(i) one hundred thousand United States dollars for the main applicant;

(ii) one hundred and fifty thousand United States dollars for the main applicant and spouse;

(iii) one hundred and seventy-five thousand United States dollars for the main applicant and up to three dependants;

(iv) twenty-five thousand United States dollars for any additional dependant under the age of eighteen;

(v) fifty thousand United States dollars for any additional dependant eighteen years of age or older;”.
